Each week the Center serves over 500 people with an average of 200 programs per month. The Center is buzzing seven days per week, from 8:30 A.M. to 8:00 P.M., and we saw about 35,000 people use the Center this year.

Teen Center attendance has doubled within the past year with nearly 200 teens on scholarship.

The **Volunteer Transportation Network** and **Good Morning Program** Check-In call service touch the lives of over 150 community homebound elders.

The **Meals on Wheels** program delivers over 18,000 meals per year.

People Plus serves as the home for the **Spectrum Generations Aging and Disability Resource Center**.

Over **200 volunteers** provided over **7,000 hours of service** this year in the areas of Community Outreach, Activities, Programs, Administration and Fundraising.
